THE ANIMAL PROTECTORATES DBA OPERATION ADOPT IS A PET ADOPTION CENTER FOUNDED TO ANSWER THE QUESTION OF WHETHER OR NOT PEOPLE WOULD ADOPT A SHELTER ANIMAL RATHER THAN PURCHASE A "PUPPY MILL PUPPY" IF THE SHELTER ANIMAL WAS TAKEN OUT OF THE SHELTER, GROOMED, SOCIALIZED AND MADE AVAILABLE FOR ADOPTION THROUGH A PET ADOPTION STOREFRONT IN A RETAIL AREA. THE ANIMAL PROTECTORATES DBA OPERATION ADOPT IS A PET ADOPTION CENTER FOUNDED TO ANSWER THE QUESTION OF WHETHER OR NOT PEOPLE WOULD ADOPT A SHELTER ANIMAL RATHER THAN PURCHASE A "PUPPY MILL PUPPY" IF THE SHELTER ANIMAL WAS TAKEN OUT OF THE SHELTER, GROOMED, SOCIALIZED AND MADE AVAILABLE FOR ADOPTION THROUGH A PET ADOPTION STOREFRONT IN A RETAIL AREA. THIS MODEL OF PET ADOPTIONS WAS FOUNDED TO TEST THE LEGISLATION ENACTED WHICH PROHIBITED THE SALE OF COMMERCIALY BRED ANIMALS IN PET STORES (LEGISLATION WHICH IS NOW LAW IN CALIFORNIA STATE-WIDE).

ANIMALS ENTERING OPERATION ADOPT GET A PROMISE THE SECOND THEY LEAVE THE SHELTERS.

THAT PROMISE IS TO RESTORE THEIR DIGNITY. THEY GET A NAME; THEY GET MEDICAL

ATTENTION; THEY GET GROOMED; THEY HAVE 2 MEALS A DAY OF HEALTHY FOOD; THEY GET WALKS; THEIR LITTER BOXES ARE CLEANED; THEY GET TREATED AS INDIVIDUALS; PEOPLE WHO WANT TO ADOPT THEM HAVE TO FILL OUT A THOROUGH APPLICATION; A VOLUNTEER IS WITH THEM EVERY STEP OF THE WAY FROM OPERATION ADOPT TO THEIR NEW HOME WHICH IS ASSESSED TO SEE IF IT IS SAFE AND THE PEOPLE ARE A FIT FOR THAT INDIVIDUAL PET; THEY ARE MICROCHIPPED SO IF THEY GET LOST WE WILL BE ALERTED; AND THEY GET A PURPLE COLLAR PROMISE THAT THEY WILL BE WELCOMED BACK TO OPERATION ADOPT IF THEY ARE EVER AT RISK OF BEING HOMELESS AGAIN.

IN 2019, OPERATION ADOPT PLACED 207 DOGS AND CATS IN PERMANENT HOMES IN CALIFORNIA AND TENNESSEE. APPROXIMATELY 27 OF THESE ANIMALS - WHO WERE HIGHLY ADOPTABLE BUT FOR NEEDING MINOR AND MAJOR SURGERIES - WERE GIVEN TIME TO HEAL PRIOR TO BEING PLACED IN HOMES. THE SURGERIES PERFORMED INCLUDED COMPLETE AMPUTATIONS, EYE SURGERIES, TEETH EXTRACTIONS, HERNIA REPAIRS AND FEMORAL HEAD OSTECTOMIES, AMONG OTHERS.
