MISSY'S OWNER DIED AND THANKFULLY A NEIGHBOR KNEW SHE HAD BEEN ADOPTED FROM US AND REACHED OUT TO US TO TAKE MISSY BACK. MISSY RECEIVED A FULLY VETERINARY EXAM WHICH REVEALED SHE HAD FAILING KIDNEYS.
